

ADMU Study Abroad Terms and Conditions

A signed and notarized waiver containing the provisions below will be required from the applicants prior to their departure from the Philippines.

1. **ELECTIVE PARTICIPATION:** I acknowledge that my participation in the Student Exchange Program is purely voluntarily and that the same is neither controlled, managed, nor directed by Ateneo. In addition, I am obligated to inform my parent/s, guardian/s, and/or primary financial sponsor/s of my elective participation in the Student Exchange Program.
2. **RULES AND REQUIREMENTS:** I agree to abide by all rules and requirements of the Student Exchange Program, and of the Host Institution. In addition, I agree to continue to abide by the applicable rules and requirements of Ateneo.
3. **EXPENSES.** I acknowledge that, with the exception of any assistance or grant which the Ateneo or the Host Institution may provide me, that I am completely responsible for all expenses related to the Student Exchange Program, including, but not limited to, my travel, living and school expenses. In addition, I acknowledge that I am responsible for securing any and all travel requirements, or any other governmental permit required, as may be applicable.
4. **MEDICAL.** I am aware of all applicable personal medical needs, and I am unaware of any health-related reasons or problems which preclude or restrict my participation in the Student Exchange I understand and agree that Ateneo or the Host Institution is not obligated to attend to any of my medical or medication needs during the Student Exchange Program, and I assume all risk and responsibility therefore. If during the Student Exchange Program, I require any form of medical treatment or hospital care, whether in the Philippines or in another country, the Ateneo or the Host Institution is not responsible for the costs or quality of such treatment or care. I agree that Ateneo or the Host Institution may, but is not obligated to, take any actions it considers necessary under the circumstances regarding my health and safety. In such case, I agree to pay any and all expenses relating thereto and release Ateneo or the Host Institution from any liability for any actions it may take.
5. **ASSUMPTION OF RISK.** I have been informed of and I understand the various aspects of the Student Exchange Program I have selected including, but not limited to, arrangements for payment, travel, itinerary, logistics, cancellation, and academic content/credit. I understand that as a Participant in the Student Exchange Program I may sustain any and all forms of personal injuries, illness, property damage, or even death as a consequence of the actions, inactions or negligence of others, travel, weather conditions, and other risks not known to me or not reasonably foreseeable at this time. I further understand and agree that any injury, illness, property damage, disability, or death that I may sustain by any means is my sole responsibility. I knowingly and voluntarily assume all such risks, both known and unknown and assume full responsibility for my participation in the Student Exchange Program.

6. **INDEMNITY.** I, on behalf of myself, my personal representatives, heirs, executors, administrators, agents, and assigns, agree to hold harmless, defend and indemnify, and release, waive, and discharge Ateneo, including its Trustees, Officers, Employees or Agents from any and all liability, including any and all claims, demands, causes of action, suits, or judgments or damages of any and every kind (including attorneys' fees), arising from any injury, property damage or death that I may suffer as a result of my participation in the Student Exchange Program, regardless of whether or not the injury, damage or death is caused by the negligence of Ateneo, including its Trustees, Officers, Employees or Agents, or otherwise.
7. **CHOICE OF LAW/SEVERABILITY:** This agreement shall be subject to and construed in accordance with the laws of the Republic of the Philippines. The Parties agree to submit to the exclusive jurisdiction of the courts of Quezon City. If any term or provision of this agreement should be declared invalid by a court of competent jurisdiction, the remaining terms and provisions of this agreement shall remain unimpaired and in full force and effect.
8. **NON WAIVER.** Failure by either of the Parties at any time to enforce any obligation against the other, or to claim a breach of any term of this agreement, or to exercise any power agreed to hereunder, will not be construed as a waiver of any right, power or obligation under this agreement.
